Laborers Agree to New Demolition Terms in CBA

The New Jersey Building Construction Laborers' District Council, Local Nos. 3 and 77 have agreed to revise the terms and conditions of their Collective Bargaining Agreement applicable to demolition for BCANJ members who assign their bargaining rights to the Association for the Laborers. Bulletin #56-12 provides a summary of the contract addendum that applies to all interior demolition on non-prevailing wage projects and the total demolition of all stick-constructed residential buildings of four families or less and all other residential buildings of two stories or less.

Agreement defined The two classifications of demolition laborers. Tier 1 consists of all Demolition Mechanics. Demolition Mechanics include all interior demolition laborers involved in dismantling work, including cutting and burning, chopping, using demolition tools or other equipment, operating bobcats or similar equipment, and all laborers working on the total demolition of structures. Tier 2 consists of all Demolition Cleanup Laborers. Demolition Cleanup laborers include all laborers performing manual labor incidental to demolition work, such as the loading and carting of debris from the work area to an area where it can be loaded onto trucks or into dumpsters for removal. Tier 1 Demolition Mechanics receive 85% of the B rate in the regular commercial agreement. Tier 2 Cleanup Laborers shall receive 75% of the B rate in the regular commercial agreement. Benefits shall be paid in accordance with the regular commercial agreement, except that the annuity contribution shall be \$1.00 per hour.

In addition to wages, work rules call for time and one-half on all hours worked over 10 hours in a shift or 40 hours in a work week, and all hours worked on Sundays and holidays shall be paid at time and one-half; no shift premiums; and full portability for all members of Laborers Local Union Nos. 3 and 77 throughout the state of New Jersey. Teamsters Settlement

A one-year agreement was reached with the Teamsters, Local 560, 469 & 408 between the Associated General Contractors of New Jersey and the Contractors Construction Labor Employers of NJ, calling for \$1.25 effective May 1, 2012, and \$0.70 effective November 1, 2012. The contract expires on April 30, 2013. A Pension Study Committee was also established to address the Teamsters' Pension Funds' severe funding deficiency that will include the findings of an independent, thirdparty actuary retained by management.
