Labor News...

Employer Burden of Proof

The employer bears the burden of proving when an union employee performs work eligible for benefit contributions – and the responsibility to make payments based on the union's records if the employer's records are not in good order. This was the decision of the First Circuit Court of Appeals, which in September vacated a decision of the US District Court in Massachusetts pertaining to ERISA contributions.

Unions Can't Block Work With Subs Hired by Non-Union CM

In August, the US Court of Appeals for the 8th Circuit upheld a National Labor Relations Board ruling that a union cannot refuse to enter into a pre-hire collective bargaining agreement with a subcontractor that works for a non-union construction manager. In the case, the non-union CM does not employ union craftworkers. It does, however, hire union subs, and the Court found the union was attempting to coerce the CM into becoming signatory by blocking work with the CM's subs, unlawful under the National Labor Relations Act.
