

LABOR RELATIONS

New in 2010...

BCANJ met with the general construction trades throughout 2010 to discuss the critical issues facing our industry. As a result, BCANJ was successful in deferring scheduled increases, modifying some of the collective bargaining agreements and developing special "market recovery" agreements for specific types of projects and markets.

Wage Freezes and Concessions

Due to pressing economic times, several of the general construction trades agreed to wage freezes or wage concessions in 2010. Those who took wage freezes in 2010 included the New Jersey Regional Council of Carpenters, New Jersey Building Laborers, Bricklayers & Allied Craftworkers, Locals 2, 4 & 5, Ironworkers, Local 399, and Dockbuilders, Local 1456. Other trades agreed to significant wage concessions. They were Atlantic County Ironworkers, Local 350, Trenton Ironworkers, Local 68, and Southern NJ Tilesetters, Local 7.

Pension Funding & Health Fund Stability

BCANJ continued to monitor the various pension plans' funding status. BCANJ commissioned an independent review by Horizon Actuarial Services, LLC, of the various pension funds to define the steps required to reach adequate funding levels within 10 years. The Review was sent to the Fund Administrators, Co-Chairs and Actuaries of the funds.

In addition to wage freezes or wage concessions, several of the trades deferred money from their Annuity Fund Contribution to self-fund the Welfare and Pension funds, which required an increase in the hourly contribution rate due to a decrease in man hours.

Market Recovery Agreements

BCANJ developed market recovery agreements with the Carpenters, Laborers and Masons during the year for the purpose of maintaining and expanding market share. Examples of projects where the market recovery agreements could apply include stand-alone chain restaurants and drug stores, storage unit facilities, car dealerships, limited-service hotels, professional and medical offices, small renovation projects, tenant fit-out projects and mixed-use projects that involve both commercial and residential work. Projects are evaluated on a case-by-case basis, using criteria and procedures established by the Union. The total package compensation is approximately 75% of the commercial rate. A formal application process is required. Members are encouraged to contact the BCANJ office if they have the opportunity to bid on a project that faces non-union competition and may qualify for the market recovery agreement.

Local 78 Agreement

The Laborers merged Local 1030, responsible for the environmental remediation jurisdiction in New Jersey, into New York Local 78. BCANJ signed an agreement with Local 78 for New Jersey only that includes more favorable conditions for work than previously prevailed through the prior agreement with Local 1030. These more favorable conditions included payment of fringe benefits on hours worked, not hours paid, time and one-half for overtime limited to Sunday, no shift premiums and more favorable portability provisions. BCANJ has formed an Environmental Contractors Council and more than 15 new environmental contractors have joined BCANJ to be party to the new agreement.



Collective Bargaining Agreements Added to BCANJ Website

In 2010, BCANJ added to the "Members Only" page all of the Collective Bargaining Agreements to which they are party. They include the New Jersey Regional Council of Carpenters, New Jersey Statewide Building Laborers, Bricklayers & Allied Craftworkers, Locals 2, 4 & 5, Operating Engineers, Local 825, and Dockbuilders, Local 1456. The New Jersey Ironworker Agreements and Southern New Jersey Tilesetters Agreement are also posted.

Future Outlook for NJ Contractors and Building Trade Unions

On April 15, 2010, BCANJ, along with several other industry organizations, held a program on "The Future Outlook for New Jersey Contractors and Building Trade Unions." Jeff Otteau, a real estate valuation expert with Otteau Valuation Group, gave a sober view of anticipated construction recovery, while Mark Breslin, a noted national speaker on construction leadership, strategy and labor-management relations of Breslin Strategies Inc., pinpointed suggestions on how labor and management can work together to survive and compete in New Jersey's construction market.

Port Authority Memorandum of Understanding

The Port Authority entered into a Memorandum of Understanding with BCANJ, CIAP, New Jersey Institute for Social Justice and the New Jersey Building & Construction Trades Council to promote career opportunities in construction to high school seniors and unemployed or under-employed individuals to prepare them to qualify for entry into the various construction trades apprentice programs. Providing a minimum of 10% of incoming apprentices are individuals who come through this special training program, the Port Authority will require on projects of more than \$1 million that all contractors be party to apprenticeship programs approved by the US Department of Labor.



Labor Binder Information

Project Labor Agreements

PLAs are comprehensive pre-hire agreements that define the terms and conditions for labor, established in advance for all parties involved in the project: the public or private owner, contractors, subcontractors and the labor force. BCANJ facilitated the establishment of many PLAs in 2010.

Labor Management Cooperatives


Labor Management Cooperatives bring together management and labor in ways to continually promote and gain market share for the union construction industry. Through many types of initiatives, labor management cooperatives are successful in delivering a positive message to private and public owners, educators and government officials on the value of using union contractors and skilled union craftworkers. Management Trustees

BCANJ members and staff serve as Management Trustees on various jointly administered fringe benefit funds for the general construction trades. In this role, they are committed to seeing that the funds operate effectively and in the best interest of union members. BCANJ's role is to assist members by providing the support and tools they need to uphold their fiduciary responsibilities. The following is a list of funds that staff and members support:

GOVERNMENT AFFAIRS

BCANJ took legislative action on the following bills that were signed into law during 2010.

Withdrawal of Bids - establishes a standardized procedure for the withdrawal of a bid on a local public works project. BCANJ won an amendment that restricts a contractor who withdraws a bid from re-bidding that project.

Construction Lien Law - addresses inconsistencies in the existing law between the residential and commercial processes, with a major focus on the residential components of filing a lien. BCANJ successfully defended against the expansion of lien claimants.

Casino Licensure - authorizes the State Casino Control Commission to create a pilot program to offer two new classifications for casino licensure to assist the struggling region with additional economic development projects.

Alternate Bids Selection - holds contracting entities accountable for how alternate bids are selected. A public body's lack of transparency when awarding contracts that contain dozens of alternates was the driving force behind this initiative.

Unemployment Insurance Fund - assisted NJ employers in averting a \$1 billion payroll tax increase that would have taken effect on July 1, 2010, if no legislative action had been taken. The law limits the payroll tax increase to \$300 million in total, which on average is \$130 per employee instead of \$480 per employee without corrective action.

SDA GC/CM Legislation - prohibits the Schools Development Authority (SDA) from restricting the ability of certain firms or persons from competing for contracts in more than one Division of Property Management and Construction (DPMC) classification or prequalification category.

Permit Extension Act - with our state facing similar economic conditions that warranted permit extensions in 2008, a measure that extends any permit approval to December 31, 2012, was signed into law in 2010. Requiring contractors to go through the costly and time-consuming permitting process all over again due to an expired permit was deemed counterproductive.


Violations of Wage, Benefit and Tax Laws - grants the Commissioner of the Department of Labor and Workforce Development the ability to determine if an employer has failed to maintain and report all records regarding wages, benefits and taxes required by State laws for one or more employees.

Business Registration Omission – allows a bidder to avoid an unresponsive bid if the bidder inadvertently omitted its business registration from the bid proposal, provided the bidder was registered before the bid submission deadline.

BCANJ continues to track the following legislative initiatives that impact the construction industry in various ways:

Naming of Subcontractors - *Support* - limits the naming of subcontractors at the time of bid to those defined by statute, i.e., electrical, mechanical, HVAC, structural steel

Construction Cost Estimates - *Support* - requires public contract bid advertisements to contain cost estimates of projected contract costs



GOVERNMENT AFFAIRS

COAH - *Support* - eliminates the 2.5% non-residential impact fee entirely and retroactively from the re-imposition of the fee in July 2010

Design-Build Legislation - *Amend* – incorporate cost as significant factor within project award processes to ensure a level of transparency for design-build team proposers

Building Maintenance - *Amend* – exclude "repair" and "improvement" from the scope of work within State-funded maintenance projects

Apprenticeship Requirements - *Support* - craftworkers performing work on certain State projects must have gone through a certified apprenticeship program registered with the US Department of Labor

Interest on Retainage - *Support* - requires contracting units to credit contractors with interest earned on retained payments that are released to the contractor upon completion of the project

State Contract Breach Legislation - *Support* - provides for an equitable adjustment in claims against the State for breaching a contract with a contractor

Third-Party Inspections - *Support* - authorizes a local enforcing agency to allow an owner to have construction inspections performed by a third party

Excess Municipal Construction Code Fees - *Oppose* - permits municipalities to use excess municipal construction code fee collections for property tax relief efforts

Standardized Bid Forms - Support - an initiative to standardize bid forms for public projects


Land-Use Application Modifications - *Support* - expand the availability of General Development Plan approvals to developments with a non-residential floor area of 150,000 sq. ft. or more on sites of 100 acres or less

Prisoner Set-Asides - *Oppose* - gives a municipality the ability through the adoption of an ordinance to create a setaside program that gives preference to firms who hire former prisoners

Statute of Limitations - *Amend* - reduces the statute of limitations period for certain actions against certain licensed professionals

3% Withholding Tax (Federal) - *Oppose* - a new law will require federal, state and local governments to withhold 3% from all payments for goods and services as a guard against tax evasion. It was originally scheduled to take effect on January 1, 2011, but the implementation date was extended one year to January 1, 2012

Numeric Stormwater Limits (Federal) - *Oppose* - the rule requires monitoring of stormwater discharge, and creates a numeric limit on actual water runoff. All construction sites are required to implement best practices to contain stormwater runoff through July 2011



EDUCATION

New in 2010...

LEED Workshop and Exam Prep

Through a partnership with the US Green Building Council-NJ Chapter, BCANJ members were offered a chance to participate in LEED Workshops and Exam Prep classes subsidized by a New Jersey Department of Labor and Workforce Development Grant. Several members' employees took advantage of this training opportunity.

LEED Study Group

Members were afforded the opportunity to participate in an interactive study group to prepare for the LEED exams. Working with AIA New Jersey, the architect-led program was held at the Association offices during five evening sessions.

FDU ASCE Conference

BCANJ assisted Fairleigh Dickinson University with hosting the ASCE Conference on April 23-25, 2010. Held at the Teaneck Campus, the weekend event kicked off with a Business Dinner Program at which student groups from the 12 participating schools presented, followed by two days of competition in the Steel Bridge and Concrete Canoe categories.

BCANJ staff worked with the FDU students in planning and promoting the program, as well as securing sponsors and judges.

Continuing in 2010...

Presidents' Scholarship Fund


Announced in March and awarded in June, this year's program recognized Samantha Burgagni, Lauren Collins, Kristen Kelly and Rachel Miller for their outstanding character, academic performance, extra curricular activities and community service. Each received a one-time scholarship of \$2,500. Since its inception in 1999, the program has granted 42 scholarships totaling \$279,000.

Student Summer Work Program

Hosting its 27th year of placing college students with BCANJ member firms to gain practical experience in the construction industry, the program welcomed eight individuals from New Jersey Institute of Technology, Fairleigh Dickinson University and Pennsylvania College of Technology at jobsites and construction offices across New Jersey.

Tuition Reimbursement Program

Even in these trying times, the Association continued to offer a tuition reimbursement program to members' employees. The program allowed for reimbursement of 75% of eligible course tuition for qualified employees, with a maximum of \$1,000 per employee for the year.



WORKFORCE DEVELOPMENT

New in 2010...

Apprentice Workshop

This exciting program was orchestrated by BCANJ under the auspices of Construction Industry Career Day. With more than 1,000 apprentices, training directors and business agents representing the majority of crafts within the building trades, Mark Breslin, a noted national speaker on construction leadership, strategy and labor-management relations, dynamically delivered his "Survival of the Fittest" program. The well-received presentation was offered at two locations: Montclair State University on Friday, October 22, and Burlington County College on Saturday, October 23.

"Build Your Career in Construction" Brochure

As construction industry employment continued to diminish, the CICD Planning Committee agreed to postpone its 2010 event. However, they continued to promote construction as a career, opting for a piece that would enlighten students on employment opportunities in both labor and management disciplines. The brochure was well-received by high school guidance counselors and students throughout the state.

Career & Technical Education Partnership: Career Cluster Advisory Committee

This collaborative statewide project, funded by a four-year grant from the NJ Department of Education, whose goal is to enhance career and technical education in the state, brings together partners in business, industry, higher education, secondary education, and labor & workforce development to address the development and implementation of model programs of study within designated career clusters. Raritan Valley Community College is the lead agency for the Architecture and Construction track on which BCANJ staff serves as an Advisory Committee member.

NJ PLACE

In January 2010, NJ PLACE was legislated as a permanent program under the New Jersey State Employment and Training Commission. Also in 2010, BCANJ was asked to serve on the NJ PLACE Subcommittee. The program's purpose is to facilitate cooperation among appropriate state agencies, employer organizations, labor organizations, schools and two-year and four-year institutions of higher education to enter into agreements to provide college credit in connection with apprenticeship programs and permit the work of apprentices in those programs to be credited toward two and four-year college degrees.


Continuing in 2010...

Workforce Cooperatives

BCANJ continued to serve as an active consortium partner on the New Jersey State Building and Construction Trades Council Youth Transition to Work Program and Helmets to Hardhats initiative; the Hudson County Schools of Technology YTTW Partnership; and the Newark Public Schools Construction Advisory Board.

Middlesex County WIB

BCANJ staff has been re-appointed to another one-year term on the Middlesex County Workforce Investment Board and will occupy the position of Vice Chair for 2010/2011, as well as maintain the seat of Literacy Committee Chair.



SAFETY

BCANJ Safety Awards Program

As the number of companies participating has increased over the years, so too have the number of members receiving recognition. In June, we congratulated 20 of our members for achieving safety excellence in 2009.

National AGC Safety Awards Program

An ongoing program since 1991, Associated General Contractors of America offers members an opportunity to evaluate their safety records from the previous year. NASA compares an AGC member's safety record with other AGC members according to the size and construction type, and distributes nationally recognized awards. BCANJ member firms participating totaled 17.

Construction Industry Safety Partnership

With a fresh approach to this program, BCANJ welcomed the following five companies into the Partnership for 2010: DePalma Contracting Inc., Hunter Roberts Construction Group, John D. Lawrence Inc., March Associates Construction, and Macedos Construction LLC.

BuildSafeNJ

This coalition, on which BCANJ members and staff are involved, continued to work to establish consistency and high standards in safety and health practices on jobsites across New Jersey. Comprised of labor and management safety professionals, they continue to share lessons learned and strive to keep safe practices paramount in the industry.


OSHA Training

Once again, BCANJ regularly provided the opportunity for members to have company employees participate in a variety of safety programs:

• OSHA 30-Hour Construction Health & Safety Class - offered three times in 2010, more than 30 individuals received certification cards

• *OSHA 502* - held in October, 14 people took the opportunity to refresh their certification to continue their outreach efforts in teaching the OSHA 10- and 30-Hour Construction programs

• *Crane & Derrick Program* - in conjunction with AGC of New Jersey's Safety Committee, BCANJ members were invited to an overview session of the new standard, provided by our labor partners. Due to the response, an expanded workshop for all members was planned for 2011.

Volume III-2010



INDUSTRY AFFILIATIONS

New in 2010...

BCANJ and AGC of New Jersey Strategic Alliance

The Boards of Trustees of BCANJ and the Associated General Contractors of New Jersey agreed to form a strategic alliance and are developing a stronger relationship by blending programs and member services. Throughout 2011 the goal is to work toward a full merger of the two associations.

Trade Association Meetings

Several meetings were held throughout the year with many of the specialty trade management organizations to collectively discuss what could be done to address economic challenges facing the construction industry. Bringing management representatives from the various segments of the construction industry together enabled constructive dialogue that we will continue to use as we meet with our labor partners.

Continuing in 2010...

Building Contractors Association of Atlantic County

BCANJ continued the administration of Building Contractors Association of Atlantic County. In that role, we facilitated Board and Membership Meetings in March, June and December. Guest speakers at those meetings included Senator James Whelan in June and Ron Esposito, Executive Director of the NextGen Aviation Research & Technology Park, in December. In BCA of Atlantic County's role as bargaining agent with Tilesetters, Local No. 7 for the southern part of New Jersey, we successfully negotiated a market recovery agreement that can be used on projects that meet a certain criteria and face non-union competition, and also secured a substantial wage concession. Members continue to receive electronic mailings of bulletins on pertinent industry issues, as well as invitations to BCANJ programs and events. The Association's Membership Directory is housed on the website. Also in 2010, both BCANJ and BCAAC actively supported the Casino Licensure Legislation and participated in the Gaming Summits.

Floor Covering Institute of New Jersey


Floor Covering Institute of New Jersey is an organization of flooring contractors who are signatory to the New Jersey Regional Council of Carpenters Resilient Flooring Collective Bargaining Agreement. BCANJ handles all administration for the organization, including labor relations, marketing and public relations, and assistance with other industry-related issues. In 2010, we created an Associate Membership category, sponsored an INSTALL Symposium in June; and hosted a meeting with NJ Regional Council of Carpenters Executive Secretary/Treasurer Michael Capelli to address the effective use of the market recovery provisions during these challenging times.

Construction Roundtable of New Jersey

BCANJ continues to provide administrative services to the Construction Roundtable of New Jersey.

INDUSTRY ISSUES

In addition to the activities BCANJ embraced throughout the year, outlined in this publication, the following industry issues have and continue to demand the Association's full attention. They are critical to the future of the construction industry and, for that reason, BCANJ will remain focused on these important topics.

Market Study

BCANJ, with the support of our management and labor industry partners, has commissioned a study that will identify future construction markets in New Jersey, along with the appropriate price points that work will command. Jeff Otteau, a real estate valuation expert, will be the lead researcher for the project that is expected to be completed by the end of the first quarter of 2011.

FASB

The Financial Accounting Standards Board (FASB) in 2010 published an Exposure Draft that proposes to revise the rules governing what employers would have to disclose about the multi-employer plans to which they contribute and about their relationship with those plans. The Exposure Draft proposes employers disclose substantial detail in notes to their financial statements, estimated to take up to two pages of footnotes for each multi-employer plan. BCANJ, along with hundreds of others, commented and as a result FASB has postponed taking any action to revise the rules that were scheduled to begin before the end of 2010 for public companies. The board now projects finalization sometime in the second quarter of 2011.

Public/Private Partnerships


Throughout the year, several meetings were held with various parties to explore the concept of public/private partnerships in order to resume major construction programs in the state, including school construction. Meetings were held with Woodbridge Mayor John McCormac and Verizon President Dennis Bone, who co-chaired Governor Christie's transition team on economic development. A meeting on the same topic was also held with Deputy Chief of Staff Wayne Hasenbalg.

Patient Protection and Affordable Care Act




