Court Upholds OSHA's Six-Month Limit on Reporting Violations

On April 6, 2012, the US Court of Appeals issued a ruling that upholds OSHA's published six-month statute of limitations on reporting violations, despite OSHA's longstanding practice of pursuing violations for up to five years. The case, begun in 2006, involved a contractor cited by OSHA for record-keeping violations going back to 2002.

Passing of Mark Ayers, President of AFL-CIO BCTD

As we posted in Hot Topics on our website, Mark Ayers, President of the Building and Construction Trades Department, passed away suddenly Easter Sunday. He had served as president since 2007, and was a 39-year veteran of the International Brotherhood of Electrical Workers. On April 16, the BCTD's Governing Board elected Secretary-Treasurer Sean McGarvey as President to succeed Mr. Ayers.

NLRB Poster Required Stopped

As we informed you via e-mail, on April 17, 2012, the US Court of Appeals issued an injunction pending appeal of a legal challenge to the National Labor Relations Board's rule requiring businesses to display its new poster telling employees of their rights under the National Labor Relations Act. With oral argument on the merits of the appeal not scheduled until September, this effectively means the NLRB cannot enforce the April 30 effective date of the rule. Thus, employers need not display the poster until fall at the very earliest.
