### Legislative News...

#### Storm Damage Estimates

As we told you in Bulletin #105-12, Governor Christie submitted storm damage cost estimates for New Jersey to President Obama and senior White House staff, federal agencies responding to the disaster, and the New Jersey Congressional delegation. Repair and response costs total a staggering \$29.48 billion, with an additional estimate of \$7.44 billion for mitigation and prevention costs that brings the overall damage assessment total to \$36.9 billion. #### Newark Mayor Signs PLA

In October, Newark Mayor Cory Booker signed a Project Labor Agreement that guaranteed union participation in some of the city's upcoming construction projects. The work covered by the PLA includes any tax-abated construction project worth \$25 million or more and any public works project over \$5 million.

#### Hess PLA

The Essex County Building Trades

Council signed a PLA with Hess for the Newark Natural Gas power plant. Skanska is the general contractor; project is estimated to create 400 construction jobs over the next 30 months.
