## **Annual Meeting**

BCANJ's final membership meeting of the year, held jointly with AGC of New Jersey, is scheduled for Tuesday, December 13, 2011, at the Robert Meyner Reception Center at the PNC Bank Arts Center, Holmdel. Cocktail hour begins at 5:30 p.m., followed by dinner and our program at 6:30 p.m., featuring invited guest speaker Lieutenant Governor Kim Guadagno. Registration information was sent to members via Bulletin #101-11.

## Gala Dinner Honors Labor Partners

As many as 300 members and guests attended BCANJ's Annual Gala Dinner on October 27, 2011, at The Palace at Somerset Park. BCANJ took the opportunity to recognize the general construction trades for their cooperation in working toward change in these challenging economic times.

#### Coffee Talk with SDA

BCANJ hosted Marc Larkins, CEO of the Schools Development Authority, and Jason Ballard, Chief-of-Staff, for a Coffee Talk at the Association office on October 21, 2011. Larkins reported on two school projects in Elizabeth and Long Branch that will be under construction before year-end and eight more that should be ready for construction in 2012. He also reviewed legacy problems, including 135 projects that still have not been closed out. Larkins discussed his mandate to reform SDA, particularly in developing design regard to procurement standards, and encouraged BCANJ members to contact him with their input. He expects to post design standards on the SDA website by the end of October.

## Members Attend Port Authority Briefing

On October, 25, 2011, BCANJ members attended a program featuring Bill Baroni, Deputy Executive Director, Port Authority of New York and New Jersey, along with the Port Authority's Chief Engineer, Peter Zipf. The Port Authority representatives outlined the projects in the capital construction budget for the next several years, totaling \$25.1 billion, and the construction schedule for some of them.

Notable projects include work on the Bayonne, George Washington and Goethals Bridges, as well as the Lincoln Tunnel, PATH trains and facilities, bus terminals, port terminals and wharves, the Pulaski Skyway and airport runways and terminals.

## FASB Issues Final Rule on Multiemployer Plan Disclosure

As we told you in Bulletin #99-11, the Financial Accounting Standards Board, FASB, issued the final rule governing disclosure of information for multiemployer pension plans. ## Safety News...

#### Safety Courses at Training Centers

In Bulletin #104-11, we distributed a schedule of the safety courses offered in November by the training centers affiliated with the general construction trades. Courses include the OSHA 30-Hour Construction Safety Course, First Aid/CPR, HazMat and other industry-related programs. ## Comment Extension Ends on Recordkeeping & Reporting Rule

The extended comment period for OSHA's proposed rule revisions on recordkeeping and reporting workrelated injuries and illnesses ended October 28, 2011. As we have told you, the current rule requires employers to report to OSHA within eight hours all work-related fatalities and inpatient hospitalizations of three or employees. The proposed revision would require employers to report any workrelated fatalities and all in-patient hospitalizations within eight hours, and work-related amputations within 24 hours. We are continuing to track the proposed rule change.

#### NLRB Poster Requirement Postponed

As we announced via an e-mail blast on October 7, 2011, the National Labor Relations Board has postponed the deadline for displaying a new employee rights poster from November 14, 2011, to January 31, 2012. #### **Construction Industry Forecast**

Reed Construction Data and AGC of America once again partnered in an October Construction Industry Forecast webinar, pushing back projections for recovery in the construction industry for at least another year, and more probably not much before 2015. The presenters report that, according to contractor surveys, 1 in 6 projects are stalled by financing issues, the number one obstacle to new construction. And, as we know, the rising cost of building materials has drastically cut contractor margins. Overall, the Producer Price Index for construction materials climbed 8.1% in the past 12 months, while the price index for new construction during the same time rose only 2.2% for industrial buildings, 2.6% for offices, 2.8% for warehouse and 3% for schools.
