## BCANJ Joins AGC of NJ In Sponsoring Safety Day

New this year, BCANJ will hold Safety Day, jointly with AGC of New Jersey, on Wednesday, October 10, 2012. On that day, participating members will place a special, coordinated emphasis on safety.

OSHA reports that injuries and fatalities on construction jobsites are declining at a rate greater than the rate at which construction activity has slowed during the past four years. OSHA attributes the decline to increasing awareness of hazards, particularly the Focus Four hazards that were responsible for more than half (56%) of the 774 construction worker deaths in 2010 – falls, electrocutions, struck-bys and caught-betweens. Safety Day is aimed at raising public awareness about using caution around construction work zones and refocusing the attention of workers on the key elements of staying safe on the job so that all those working on member sites return home safe and sound at the end of the day.

Active members received Bulletin #76-12 promoting the value of Safety Day and suggesting a variety of activities members may wish to incorporate into and in advance of Safety Day. The bulletin also included a registration form for participation and an opportunity to order a Safety Day Banner to display on a jobsite. ## NJ DOL Sponsors OSHA Safety Training in October

As we told you in Bulletin #75-12, the Northern New Jersey Federal Safety & Health Council, in partnership with the NJ Department of Labor and Workforce Development and the Atlantic OSHA Training Center, will conduct three OSHA training programs this fall. In October, the OSHA 10-Hour General Industry Safety & Health Course and the OSHA 10-Hour Construction Safety & Health Course will be offered as two-day courses.

A three-day OSHA 7600 Disaster Site Worker Course is scheduled over consecutive weeks in late October and November. The cost for the OSHA 10-Hour classes is \$5 per person, per class. There is no charge for the OSHA 7600 Disaster Site Worker class, but participants must hold OSHA 10-Hour or OSHA 30-Hour certification. #### AGC of America Announces Online Safety Training

AGC of America announced this month it is collaborating with ClickSafety, an OSHAauthorized training provider, to offer construction safety courses online and discounted for employees of AGC member firms. More than 300 courses, plus 70 courses in Spanish, will be available at a 10% discount.

The OSHA 10-Hour and 30-Hour Construction Safety & Health courses top the list, along with Focus Four prevention courses in fall protection, electrocution, struck-by and caught-between. Other offerings include the 10-Hour General Industry Safety & Health, 10-Hour Road Builder, 10-Hour Cal/OSHA, Mold in Construction and the EM 385-1-1 safety course required for Army Corps of Engineers projects.

In our annual check of OSHA's most frequently cited standards for the last fiscal year, we find they are much the same, with Scaffolding (1926.451) in the #1 spot, Fall Protection (1926.501) at #2, and Ladders (1926.1053) at #8.

# London Olympics Construction Proved Safest in Years

The 2012 London Olympics reported zero fatalities occurred during construction of Olympic Park on an abandoned industrial site in the East End. That is in glaring contrast to other recent Olympics. In 1996, two workers died during construction of the Barcelona Olympics...one worker died during the 2000 Sydney Olympics construction...14 were killed in Greece in 2004...and 10 died in Beijing in 2008. The overall incidence rate was significantly lower than the average in Britain – on a project that employed 46,000 workers for 77 million manhours.

It helps workers and supervisors calculate the heat index and risk level for employees working outdoors.
